Practitioners of historical dialogue and accountability from conflict, post-conflict and post-dictatorial societies will have the opportunity to engage in training, networking, project work, academic and applied study. The comprehensive program provides Fellows with the opportunity to hone practical skills in fundraising, advocacy and leadership, to develop a deeper understanding of dealing with the past, and to foster mutually beneficial relationships with their peers and with international and non-profit organizations in New York City and Washington, DC.
